




Plastic packaging waste recycling





Non-OECD destinations


- Last minute (31 Dec) application of notification from 1 Jan
- Requires amendment to EU transposed legislation to include non-OECD as green list (June)
- Manifesto commitment to ban plastic waste to non-OECD – consultation on exports later in year
- Not big tonnage but some materials difficult to recycle elsewhere

Plastic packaging waste export destinations





Turkey

• Turkey now biggest export market by far (30.9% compared to 16% NL)

New rules for reprocessors applied in Sep 2020

- Import license
- 50% import quote
- New import rules from 1 January
 - Prohibit plastic produced from 'mechanical treatment' (EWC 19 12 04)
 - Prohibit mixed plastic



Turkey vs China

Basel convention changes

- From 1 Jan, Basel convention changed green list coding and permitted plastic types – B3011 and Y48
- PVC and mixed plastics beyond PE/PET/PP to be notified
- Exports to be 'almost free from contamination' and 'almost exclusively' single polymer of allowed mix
- UK Agencies apply 'de minimus' position
- EU developing Correspondents Guidelines no 12 with likely % contamination allowance
- EU allow intra-EU movement of PVC and broader mix under green list





EU destinations for plastic packaging waste



Northern Ireland Protocol



- Comes into force mid-March
- Treated as EU Member State for receipt of waste' purposes
- Therefore benefits from different EU applications of Basel
- Waste to NI from GB must be green list or notifiable
- Waste from NI to GB under normal GB duty of care

Other EU-related issues

- UK no longer party to EC waste related developments eg CG12
- 'Country of origin' issues with reuse into some MS
- Notifications becoming more difficult eg Spain now central rather than region
- Potential for increased legislative variation between parts of UK
- Opportunities to review historical EU controls eg EWC codes

Future infrastructure requirements

- DRS + EPR targets will see demand for increased plastic packaging recycling
- UK national targets will see increasing demand for separate nation capacity
- Tighter export controls will increase need for UK infrastructure
 - Improved processing prior to export
 - Increased UK reprocessing capacity
- Recycled content tax helping to drive demand for recyclate but price of virgin still main driver
- Investment required now to meet future demands but without policy intervention, will market deliver necessary investment?
- Heavily dependent on EPR for funding but that is unlikely to be available until 2024
